## Water Use Efficiency Award Nomination Criteria

The Mesa Consolidated Water District (Mesa Water) Board of Directors established the Water Use Efficiency Award as part of Mesa Water’s customer outreach efforts in order to promote water use efficiency in the community. This program provides an opportunity for Mesa Water to honor, promote, and publicize its customers’ wise water use, including featuring award recipients -- and their gardens/landscapes -- on [www.MesaWater.org](http://www.MesaWater.org) and in Mesa Water’s newsletter, which is distributed throughout the community and water industry. Self-nominations are welcome, and listed below are nomination criteria to be eligible for Mesa Water’s Water Use Efficiency Award.

- 1. Must be a Mesa Water customer:**
  - **Business/Commercial (hotels, mixed-use, office, retail, restaurant, etc.);**
  - **Civic (government);**
  - **Nonprofit;**
  - **Industrial (manufacturing, etc.); or,**
  - **Multi-Unit Residential (apartments, HOAs, etc.).**
- 2. Must have an ongoing water use efficiency program of at least one year in duration, and must be committed to continuing the water use efficiency program.**
- 3. Must be able to provide at least three key elements describing its water use efficiency program, and must be able to provide evidence of annual water use savings.**
- 4. Must have a positive reputation.**
- 5. Must be a willing Mesa Water “supporter” and award recipient (i.e., send a representative to receive the award at a Mesa Water Board meeting, partner in Mesa Water public relations, etc.).**
