DISCUSSION

Annually, the Board of Directors (Board) reviews the calendars to set the date and time for the meetings to be held the upcoming year.

In 2026, Board meetings will be held on the second and fourth Wednesdays of each month at 4:30 p.m. Staff recommends canceling the April 22 and October 28, 2026 Board meetings due to workshop scheduling and cancel the November 25 and December 23, 2026 Board meetings due to the holidays. In addition, the November 11, 2026 meeting falls on Veteran's Day; staff recommends rescheduling this meeting to Tuesday, November 10, 2026 at 4:30 p.m.

While staff is not recommending further cancellations, the Board is advised that the February 11, 2026 meeting closely coincides with the CalDesal Annual Conference, the February 25, 2026 meeting coincides with the Urban Water Institute Spring Conference, the June 24, 2026 meeting coincides with the American Water Works Association ACE 26 Annual Conference and the December 9, 2026 meeting coincides with the Colorado River Water Users Association Annual Conference.
