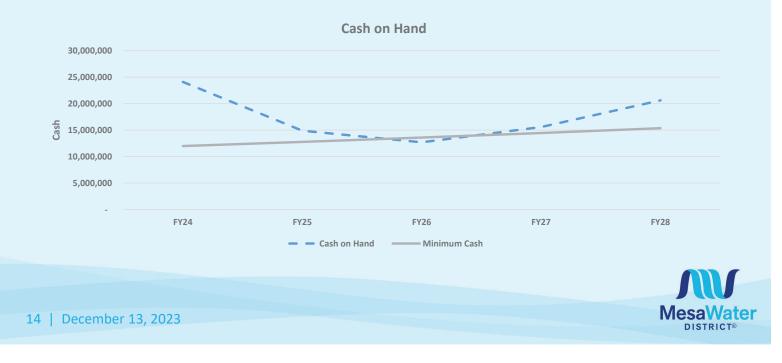

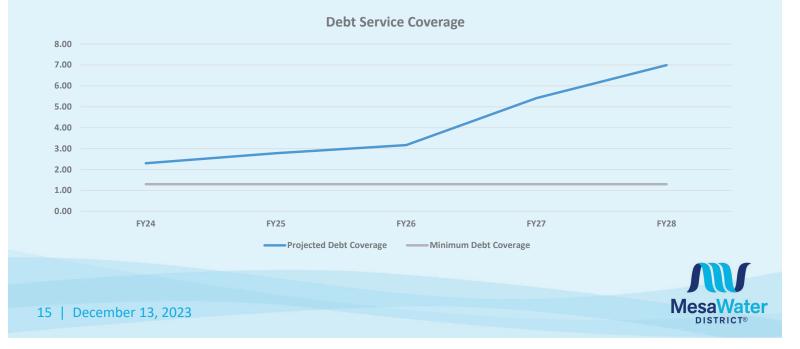
### Proposed Financial Plan – Days Cash

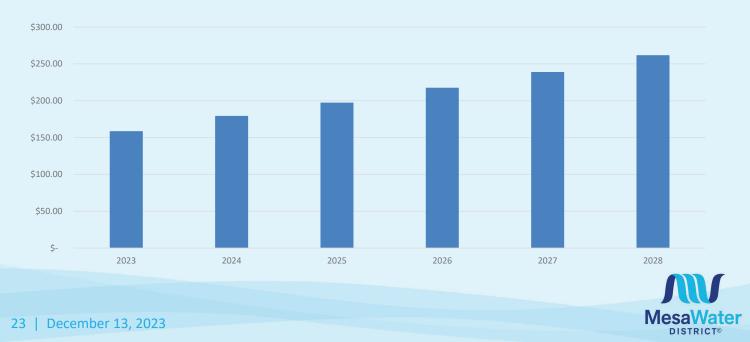

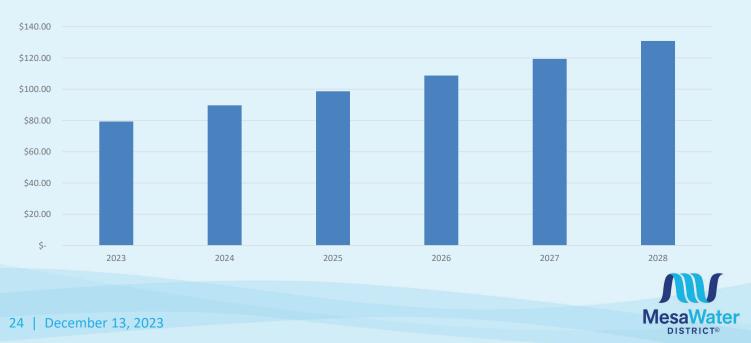

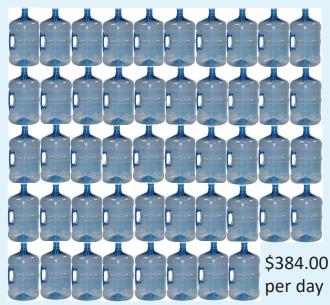
#### Average Single Family Bi-Monthly Charges
