



### California's Misguided Water Policy: **Embracing Scarcity Instead of Abundance**

Consistently Denies/Thwarts Practical Supply Solutions:

- Bias against private financing
- Overstates environmental impact, activists dominate debate

Imposing Statewide Urban Water Rationing via SB 1157:

- Ignores decades of efficiency improvements
- Relies on flawed cost/benefit analysis

Pursuing Solutions of Marginal Value and Massive Cost



### SB 1157 – Downside to Mesa Water, Downside to Mesa Water's Customers

- Already hard to get supply projects approved
- Undermines incentive to invest in supply
- Massive cost for new meters and monitoring
- Rationing *increases* cost to customers
- Expensive new appliances don't work well
- Enforcement costly and annoying
- Urban landscape becomes heat island

## Strategic Message: Water Conservation Has Reached its Limit

Extraordinary Achievements Already:

- 1985 urban water use 7.5 MAF, population 25 million
- 2023 urban water use 7.5 MAF, population 40 million

New Proposals Yield Diminishing Returns:

- Implementing SB 1157 will cost est. \$7 billion
- Total projected savings, 400,000 AF/year

SB 1157 Barely Dents CA Water Diversions >60 MAF/year



# Strategic Message: Water Abundance is Feasible & Sustainable

Investment in Practical, Environmentally Responsible Water Supply Projects = Resiliency, Affordability & Equity

We Need an All-of-the Above-Approach to Investment:

- · Wastewater reuse and storm runoff harvesting
- Off-stream reservoirs, aqueduct upgrades
- Fish friendly Delta diversions to huge storage aquifers
- Large scale desalination

### Solution: Flexibility in SB 1157 Rulemaking



- Surplus can't shut down assets
- Micro-monitoring is overkill
- More water spreads overhead
- Costly enforcement
- Harmful to urban ecosystems
- Undermines resilience

Implementation of 1157 must encourage, not discourage, investment in more water supply

### Solution: Fish Friendly Delta Diversions



- Cost est. less than \$7 billion
- 200-acre channel, 15 TAF/day
- "Uncaptured" Water 10 MAF/yr
- Underground storage
- Parallel project levee upgrades
- Tunnel's future uncertain
