- In order for the Smart Timer to be issued to you, all Program requirements must be met.

ELIGIBILITY REQUIREMENTS

- The installation address must be in the Mesa Water District (Mesa Water®) service area (you may visit MesaWater.org/Service Area to determine if you are within the Mesa Water service area). The installation address or property must currently receive water service from Mesa Water.
- Applicant must be a current Mesa Water customer of record at the installation address listed on the application.
- Smart Timers are available for the Customer of Record for residential properties.
- To be eligible, properties must currently have a landscaped area served by a functioning automatically operated irrigation system and a functioning automatic irrigation controller installed at the time of Application Form submission.
- All installation projects must comply with any applicable Federal, State, and local laws as well as applicable CC&Rs and/or HOA restrictions.
- The installation address' water account must meet the minimum yearly average consumption requirements as stipulated by Mesa Water.

PROGRAM TERMS & CONDITIONS

- Since funding is limited, this offer is limited and available on a first-come, first-served basis to eligible participants until funding is depleted or the Program ends, whichever occurs first. Submitting an Application Form does not guarantee you will receive a Smart Timer. If funding is exhausted, or the Program ends, prior to issuing your Smart Timer, you will not receive a Smart Timer through this program. However, customers may instead purchase a Smart Timer separately and may be eligible to instead receive a rebate through the currently administered local or regional water efficiency rebate program.
- The provided product(s) must be installed and remain within the Mesa Water service area at all times.
- By applying for a Smart Timer in this Program, personal information listed on your Application Form may be subject to disclosure to requesting parties pursuant to the California Public Records Act, since Application Forms are generally considered public records.
